## 2. We collect and use your personal data...

# ...to answer your inquiries you sent to us by direct message.

We process your personal data in order to be able to answer your inquiries sent to us by means of a direct message via the respective social media network or platform.

To do this, we always process your name as selected by you for your social media user account. In addition, we process all personal data that you send us with your direct message. In order to answer your inquiry correctly, we will redirect it to the relevant department within IGL, which can best answer the respective inquiry. An answer to the inquiry will either be sent by the relevant department or we will send the answer formulated by the department directly via direct message via the respective social media network or platform.

We store your data for as long as it is necessary to answer your inquiry.

### ...to follow up and report on posted adverse events.

As a pharmaceutical manufacturer, Institut Georges Lopez (IGL) is legally obliged to collect, document and report your posts on our social media presence to the responsible health authorities if they describe events relevant to drug and medical device.

This may also contain personal data about you if you have published it in your posts.

We store this data for the duration of the legal retention period in accordance with the legal obligations existing in the respective countries, which also determine the duration of the respective retention.

We process your data to fulfil this legal obligation to which Institut Georges Lopez (IGL) is subject, Art. 6.1.c GDPR, and the fact that you have published this information yourself in the form of a posting on the respective social media network or platform, Art. 9.2.e GDPR.

## ...to gain insights in our and your online presence.

Together with some social media providers, with the help of profiles made available by the respective social media provider, we have the possibility to produce statistics on your visits, interaction and content of the respective online presence.

These statistics are anonymous to Institut Georges Lopez (IGL) and do not enable Institut Georges Lopez (IGL) to identify individual visitors.

We use these statistics in order to adapt our online presence with the respective platform or network to best suit the preferences and interests of its users.

We process your data based on our legitimate interest in providing an adequate online presence which meets the demands of the users, and the fact that this interest is not outweighed by your interests, rights and freedoms, Art. 6.1.f GDPR.

#### 3. You have the right to...

### ...obtain confirmation

You have the right to obtain from Institut Georges Lopez (IGL) confirmation as to whether or not personal data concerning you is being processed, and where that is the case, access to the personal data. You can submit an application by post or e-mail to the above address.

#### ...get your data rectified

You have the right to request from Institut Georges Lopez (IGL) the rectification of inaccurate personal data concerning you. Please contact the above addresses.

### ...ask for erasure

You have the right to request from Institut Georges Lopez (IGL) the erasure of personal data concerning you under the prerequisites put up in Art. 17 GDPR. These prerequisites inter alia provide a right to erasure, if data is not necessary for the purpose it was collected for, in case of an unlawful processing of personal data, if the personal data have to be erased for compliance with a legal obligation in Union or Member State law to which Institut Georges Lopez (IGL) is subject, or if you have withdrawn your consent and there is no other legal ground for the processing. To exercise the aforementioned right, please contact the above addresses.

## ... have your data restricted of processing

You have the right to request from Institut Georges Lopez (IGL) the restriction of processing if the prerequisites of Art. 18 GDPR apply.
